ARTworks: How the Art you specify affects health & safety

Core of Knowledge Topic: _____

Duration of Course: Eight hours

I. Instructors:

II. Course Description:

This eight-hour live course meets requirements toward the 40-hour recertification program required for certified administrators. Instructors will discuss how art and architecture promote health, safety and welfare in society and culture and discover how these trends expand opportunities for your facility.

III. Course Objectives:

By the end of the course, participants will:

- Learn how art and architecture are used in community programs to create healthier and safer communities.
- Discover how interior design, architecture and landscape architecture may expand opportunities for healthcare, community, corporate, and residential environments.

Define how artistic and architectural programs help ensure the safety of visitors and employees through pattern, texture, and color. Identify how art impacts branding, signage, color, lighting, and subject matter for the public and for employee morale and health. We will use Rodale Media, Apple Computer and Hall Office Park in Frisco, TX.
